ROADS

As you know from riding the roads, all pot-holes have been hot-patched and rolled. Frank Rhoades of Unionville did this job for us. It is the same crew who hot-surfaced Covered Bridge Drive hill.

Our biggest job yet to do it hard surfacing The Loop (Covered Bridge Drive from Lot #204 and around Liberty Lane to where it joins Covered Bridge Drive at Powder Horn Lane.)

Letters have been sent out to contractors requesting that they meet with Dave Kalish and Lee Graham to inspect the job. We would not expect to receive Proposals back for at least a week following the meeting on May 27, therefore, there isn't any way we can set out a starting date. Of course, if all of the Proposals come back over budget (\$65,000), we would not be able to work on the complete project.

We do have in mind an alternate plan. We would go back to the original budget for the year and begin cleaning the ditches, probably one of the most important parts of building a road. If water doesn't run off the road and get carried away, the water gets under the road and forms soft spots and comes through the surface. In the winter, water under the road freezes and breaks up the hard surface. Then, in 1995, we could go ahead and hard surface the road.

Well, let's hope we can work within the \$65,000 we can afford.

RESERVATIONS FOR THE CLUB HOUSE

From the Board of Directors

The 94-95 Board of Directors, utilizing the previously established list of STANDARD COMMITTEES, agreed among themselves to accept the responsibility of

serving as chairpersons, as follows: FINANCE COMMITTEE - Raymond Mowchan; PUBLIC RELATIONS - David Kalish; ARCHITECTURAL AND COMMUNITY GOALS - Norman Kloker; BUILDINGS AND GROUNDS - Samuel Driver.

Board members will also serve as ex-officio members for the SPECIAL COMMITTEES: ROADS - David Kalish; CLUB HOUSE OPERATIONS, ENVIRONMENTAL AND BEAUTIFICATION, ENTERTAINMENT, MEMBERS ACTIVITIES, POOL OPERATION and RECREATION (all combined into one special committee) - Sam Driver

Responsibility for RULES, PERSONNEL, ADMINISTRATION, and LONG RANGE PLANNING were assigned to the Board as a whole.

Because of the urgency to have the ROADS COMMITTEE assume its responsibilities, the committee was organized as follows: Chairperson H. L. Graham assisted by Bud Morley, Leonard Lohr and Kemper Deane.

The ROADS COMMITTEE has, with the advice of the road consultant Mr. John Taggart, analyzed the condition of the 'Loop', prepared specifications to hard surface the "Loop", and invited road contractors to make bids. Pending a review by the consultant and the acquisition of loans from the club members agreeable to underwriting the cost of the project, the Board of Directors selected the bid of F & H Paving, Inc.

The board established a "condition of permit" to be required by the ARCHITECTURAL COMMITTEE when members request a permit and approval for buildings to be placed on their lot(s). The fee is to be held in escrow and refundable, with interest, when work is satisfactorily completed. The County Building Department will be aware of this regulation. The fees will be as follows: Accessory Building \$100; Garage \$300; and Home \$500.

BUILDINGS AND GROUNDS

The Buildings and Grounds Committee met Thursday, July 21 at 7:30 p.m. at the clubhouse. Responsibilities of this committee will include governing Malvern's buildings and grounds, pool operations, environmental concerns, clubhouse activities and member activities (entertainment, athletic, recreation). The committee membership includes

The current agenda involves updating the rules for the clubhouse, pool, and lake. 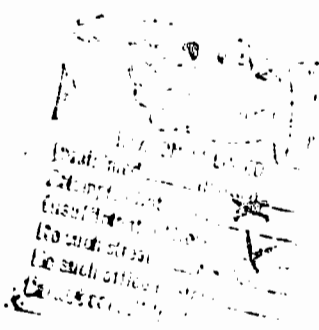
There no longer is a lifeguard at the swimming pool and there will not be one for the rest of the season. Please take note of the rules which have been posted at the pool.
