# NOVEMBER BOARD DECISION

By resolution, the Board has established the Annual Fee at \$225 per lot and the deadline for payment is January 1, 1995. The special assessment fee has been set at \$125 per lot with a new deadline for payment of June 1, 1995. Anyone wishing to pay the full \$350 in full on Jan 1st may do so and this would be greatly appreciated.

The following regulation is being prepared, "Only registered and insured motor vehicles, operated by a licensed operator may travel on the roads or common property of Malvern Club Inc. This regulation is to be in keeping with those utilized by the Commonwealth of Virginia, including the requirement that parents are responsible for under age persons." Legal wording to be finalized by our Attorney for a membership vote at the April General meeting making this and amendment to our Deed of Dedication as well as our By-Laws. allowing for stricter Enforcement.

Club Member Curt Nellis made an excellent presentation on the Fire Departments entering into the Department Of Forestry grant program for the installation of Dry Hydrants within the County. The Department has three available for the upcoming year with One reserved for Malvern. The Board has agreed to purchase a flexible suction hose needed to hook up to these hydrants and donate it to the Fire Department. The cost is \$325, a very small price to pay for the Great increase in Fire Protection that our community will receive
