ARCHITECTURAL COMMITTEE

It is the expressed purpose of the Architectural Committee to assist any Malvern Club member in obtaining the proper authorization for new construction or modifications to existing property, in accordance with the Deed of Dedication.

In a meeting on January 23, 10 a.m., the Architectural Committee agreed that from this day forward, all new construction or modifications (both environmental and structural) must be submitted to the committee on the proper form obtainable from any member of the committee, and an accurate plat/survey of the property. No rough sketches of the property and its boundaries will be accepted.

Any trees that have been approved for cutting should be removed from the site, especially trees and fallen debris that is in the view of surrounding neighbors, or roadways in the Community. *It should not be left on the side of the road to rot.*

CONSTRUCTION PERMIT

First step: Apply to Madison County for a Construction Permit which will provide a "Schematic drawing of sewage disposal and/or water supply system and topographical features." \$25.00. Have a copy made (\$.25) and send or take to the Architectural Committee.

SPECIAL BOARD MEETING

A special meeting of the Board of Directors was called and met at the clubhouse, Saturday, January 14, at 7:30 p.m. All members of the Board were present. The meeting was chaired by President David Kalish.

21 residents attended the meeting which was called on very short notice. A question was raised concerning the action taken by the Architectural Committee in approving a request by the owner of Lot #208. The Board, at the time of the meeting had a hand-drawn, unsigned application which resulted in a conference with our lawyer to determine the action to be taken to rectify the situation. Following the lawyer's advice, a letter was hand delivered to the owner of Lot # 208 stating there was a violation of Item # 13 of the Deed of Dedication. Subsequently, the Board received a properly signed application. The Board now has on hand a copy of the Construction Permit for Lot # 208 showing the location of the residence, septic field and well. Should changes be considered, a new Permit must be obtained from Madison County.

The item of agenda concerned procedures necessary to be taken by the Architectural Committee and the Board to prevent the indiscriminate cutting of trees on building lots. Item # 13 on the Deed of Dedication expressly forbids the cutting of any deciduous tree of more than six (6) inches in diameter without prior written consent of the Board of Directors. The item of contention was whether all of the trees cut on Lot # 208 had to be cut for house and drainfield construction.

The question was raised concerning procedures regulated by Madison County and whether these had been properly followed. County ordinances require a potential builder to secure permits and pay fees prior to any construction. The site must be percolated and approved by the Health Department. The plan for the location of the residence, septic field, and well is prepared by the Health Department and is kept on file at the County Offices.

The Board has decided to meet with the County Administrator and review County procedures for the home builder.

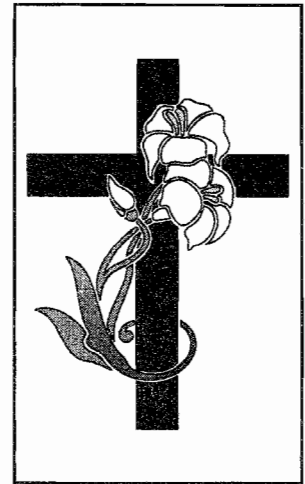
We in the Malvern Community develop procedures of our own in order to preserve the quality of life we have here and maintain the value of our property in the market place. It takes decades for a tree to grow to maturity and only ten minutes to cut it down. There is no argument about clearing space for a house and septic field. This has to be done, but to go through a three acre lot and cut all of the marketable trees destroys the market value of the lot and also of those lots around it. Therefore, Item # 13 in the Deed of Dedication.
