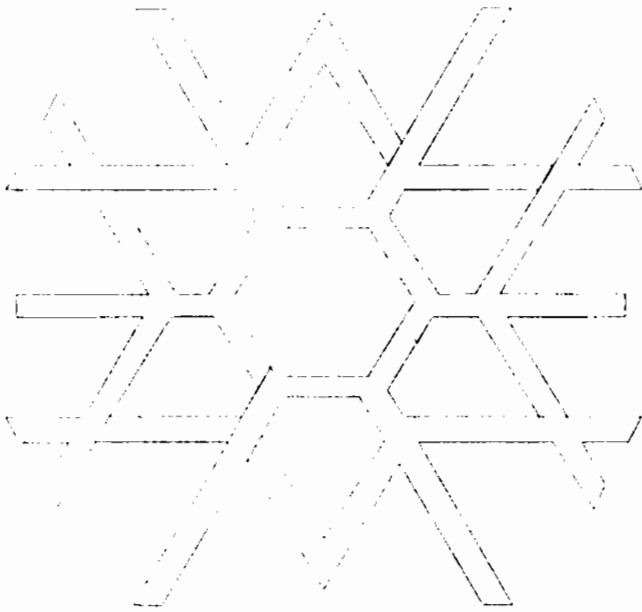

## *~ A Message from the President ~*

Your volunteer Malvern Board wishes you and your family Happy Holidays. Our unique sub-division has experienced many new homes and lot owners this year. With several homes in the process of completion on Old Forge and lot sales on Pine Torch, our latest completed roads have a lot of activity.

It is the Board's goal to pay off our 5-year road loan in 4 years, thereby allowing us to look at paving our remaining gravel roads. To accomplish this, we recently refinanced our loan with Wachovia for a 3% rate reduction that will save Malvern \$15,000 in interest over the life of the loan. We would like to thank Malvern resident Doug Fears, V.P., Wachovia, for his assistance in this transaction.

In 2002, we hope to make early payment on our loan as we did last year, to save additional interest. Again this year, we are asking lot owners to pay both dues payments in January to help accomplish our goal of paying off our loan 1 year early. In addition, this is a great help to your volunteer Treasurer and his bookkeeping. We also find that paying both dues in January is simpler for lot owners in that they forget to make the June payment and then

## **Malvern Electrical Power Outages**

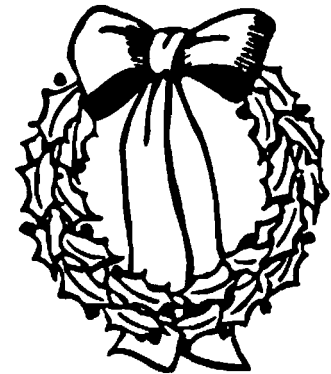
Malvern residents receive electricity from two companies: Allegheny Power and Rappahannock Electric Co-op. Intermittent power loss occurs under both systems - generally for just a second or two - but on a frequent basis. While these outages are usually short in duration, they create both a nuisance and potentially costly problems.

To date, the companies have not provided residents with an explanation for these frequent outages or whether an upgrade in equipment is under study to eliminate or reduce the frequency. A few residents have called Allegheny Power and are expecting a visit from a company representative to review the complaint. 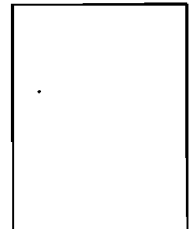
